

succession and inheritance tax reliefs?

CARBON OFFSETTING, PEATLAND RESTORATION AND FORESTRY



The Woodland Carbon Code and the Peatland Code are voluntary nature based schemes. They set quality assurance standards for woodland creation and peatland restoration projects and enable the sale of independently verified carbon units. Both codes are backed by the UK Government and characterised by strict codes to safeguard the integrity of carbon credits. These are multi-generational arrangements with decisions made now affecting the land for many decades.

We are experienced in helping landowners to understand and assess the risks involved and to ensure that decisions made today benefit, rather than hinder, the farm or estate in the future.

We also advise in the sale and purchase of existing plantations including dealing with obligations in respect of historic grants from Scottish Forestry.
